

BA/MIA Checklist: International Studies - International Business (IS34)

Overview

Eligibility for admission to the BA/MIA requires students to be declared as an International Studies – International Business major, have a major GPA of 3.4, a cumulative GPA of at least 3.0, and to have completed lower and upper division department-based course work. All lower and upper division coursework must be taken for a letter grade of C- or better. Applicants to the program are admitted in the spring quarter of the Junior year. Upon admission, the student must change their major to IS35 International Studies - International Business (Jt BA/MIA). There is a required internship between the senior and graduate year.
